

### **Holy Cross Catholic Co- Curricular Athletics Secondary School Contract**

- A1) Philosophy: This contract is intended to outline the expectations that we have for coaches, student athletes, and parents/guardians. Co-curricular athletic programs at Holy Cross exist to provide student/athletes with the oportunity to develop skills, compete as part of a team and represent the school at a high level. It is the goal of the athletic program to strive for each individual to excel in their role on the team. We expect that all players, coaches and parents will support this effort and demonstrate good sportsmanship at all times. Parent/guardians whose conduct is injurious to the team may jeopardize their son/daughter's eligibility. Although winning is not the only goal of the athletic program, it remains as a goal and every player participating should recognize this reality in that it may affect their playing time. In order for any student/athlete to be eligible to participate, this contract must be signed by the coach, student and parent/guardian.
- **B1)** Eligibility:In order to be eligible for extra-curricular athletics at Holy Cross, a student must be in good standing. This means that students will carry a full course load, exhibit positive effort, attitude, work habits, and attendance throughout the entire semester in which they are enrolled. Academic checks occur during the reporting periods. Student/Athletes are expected to be positive role models for their peers and to show respect for the moral and religious values which guide our Catholic school system. Loss of eligibility for reasons of not being in good standing will be assessed by the Eligibility Committee and confirmed by the Principal. Students may regain their eligibility only after a review for the period of the suspension. A coach or staff advisor may assess further sanctions at their discretion. (PLEASE SEE CODE OF STUDENT BEHAVIOR)
- **C1)** Conflicts:To prevent the problem of conflicts arising when playing on a Holy Cross team, the athlete must inform their coach(es) of any other activity which would prevent a full commitment to their school team.
- **D1) Player Obligation:** I accept my role on this team in the role that I have been assigned. I will maintain academic eligibility and I promise to uphold the spirit of the school and sportsmanship at all times
- **E1)Parental Obligation:** I have discussed with my child, thier role on the team. In the event that I have a serious concern with the approach taken by a coach, I will wait until the next school day before discussing my concern with the coach.
- **F1**) Coach's Obligation: I have discussed the role of each individual with them and I will assist the student athlete to develop to their highest potential, to be an example of sportsmanship and discuss any concerns I have with the individual before taking action.
